She also said with less parked cars, from her experience, she thinks this would increase the speed of some drivers.

Jo was also shown the state of the Great North Road between the Goldstraw Lane and Dale Way roundabouts.

Councillor Cullen to suggest on a map where kerbs could be dropped to alleviate the problem.
